3. OBJECTS
1. To make arrangements for imparting quality education particularly in rural areas from Nursery onwards.

 6. To manage the proper utilisation of the funds/income derived, for the welfare of the society.
 7. The profit of the society will not be distributed amongst the members, but will be utilised for the welfare of the society.

GOVERNING BODY

1. Shall be elected by the General House.
2. Members shall hold office for three years and can seek re-elections.
3. Governing Body consisting of seven members shall elect President, Vice-President, Secretary, Manager-cum-Cashier etc. from amongst themselves.
4. The Secretary shall call the meetings of the Governing Body quarterly or as and when required, with the consent of the President.
5. Governing Body shall exercise powers of management attending smooth working and development of the Society.
6. In the absence of Vice-President, members will elect the Chairman amongst themselves.
7. The Governing Body is the Executive Committee of the Society.
8. Shall prepare and present before the General House, annual audit report of the Society.
9. Shall consider applications for membership.

PRESIDENT


President will preside over the meetings. He will have a casting vote right. He will be responsible for smooth working of the society.

VICE PRESIDENT

Vice President will exercise the powers of the President in his absence.

SECRETARY

1. He shall summon the meetings of General House and Governing Body.
2. Shall record the proceedings of the committee.
3. Shall keep all records of the committee.
4. Shall make all correspondence on behalf of committee.
5. Shall perform duties assigned by the President from time to
